(C) Project of the dissertation

1) Update of the planning of your research program

In the past year I tried to give a more accurate scope to the main problem of my dissertation, namely the problem of the emergence of the history of science as a legitimacy venture through the age when modern science came to full consolidation, the XIX century. Above all, I engaged with a thorough review of the literature on the matter,

and I eventually resorted to focus on three national contexts where the history of science was pursued during this century: Victorian England, Post-Revolutionary and Post-Napoleonic France, and Germany in the age before unification.

The next year will be devoted to the writing of the first chapter of my dissertation, and namely to the peculiar fashioning the history of science assumed in the Cambridge circle which gathered around William Whewell and the British Association for the Advancement of Science.
